Explanation of Responses:

- These shares were granted as market share units and vest one-hundred percent on May 14, 2015, subject to acceleration and cancellation upon the occurrence of certain events. Each market share unit converts into the number of shares of common stock determined by applying a payout factor to the target number of shares on the vesting date, ranging from 0% to 200% of the number of market share units granted. The payout factor is the ratio of the average of the closing prices during the 90-day period immediately preceding the vesting date divided by the average of the closing prices during the 90-day period immediately preceding the date of grant.
- These shares were granted as restricted stock units and vest twenty five percent on each of May 14, 2013, May 14, 2014, May 14, 2015 and May 14, 2016, subject to acceleration or cancellation upon the occurrence of certain events.
